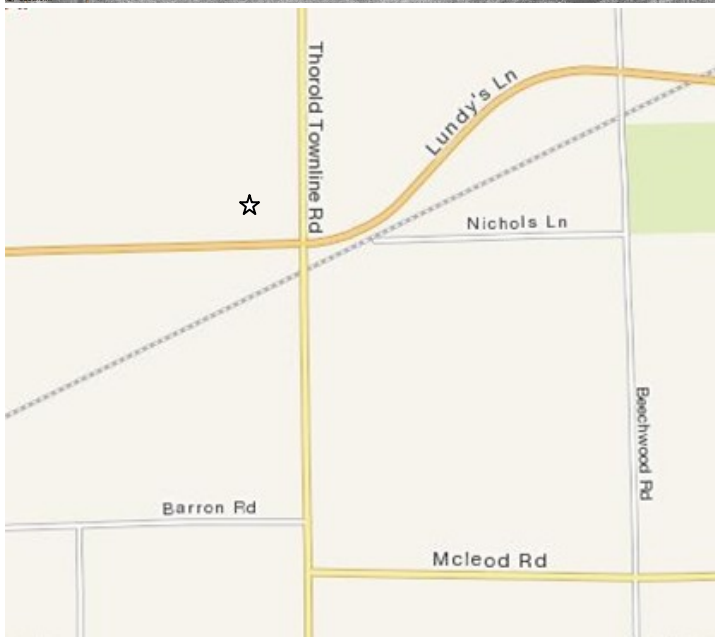

SECTION 20: HIGHWAY COMMERCIAL HC ZONE - HIGHWAY 20 EAST OF CANAL

- (16) convenience store;
- (17) farm produce outlet;
- (18) gasoline bar and/or automobile service station;
- (19) garden centre;
- (20) hotel/motel;
- (21) parking lot;
- (22) recreational and entertainment facilities;
- (23) recreational vehicle establishment;
- (24) restaurant;
- (25) restaurant, drive-thru;
- (26) service shop, merchandise;
- (27) veterinary hospital;
- (28) wholesale establishment;
- (29) accessory buildings and structures to the permitted foregoing uses and in accordance with the provisions of Section 20.3.
